VALECRAFT HOMES (2019) Limited presents the "Score Your Mortgage Payments for a Year" Draw

OFFICIAL DRAW RULES

1. DRAW ELIGIBILITY PERIOD.

Valecraft Homes (2019) Limited Score Your Mortgage Payments for a Year Draw (the "Draw") eligibility started at 00:00:01 AM Eastern Time ("ET") on January 1st, 2023, and ends at 11:59:59 PM ET on June 30, 2024 (the "Draw Eligibility Period").

2. ELIGIBILITY

Draw is open to new or existing owners of Valecraft built homes in Shea Village Stittsville or Place St. Thomas Embrun who are Mortgagors/Chargors and who have or will have a mortgage (other than from a private lender) on their home between January 1st, 2023, and close of business on June 30th, 2024, and which mortgage is or will still be in existence during 2024. The Mortgagors/Chargors must be legal residents of Canada, who have reached the age of majority in the Province of Ontario as of the date of the draw.

For the purposes of this Draw, Mortgagor(s)/Chargor(s) ("Mortgagor") means a person or persons who own a single-family residence (including a condominium unit or townhouse) built by Valecraft Homes (2019) Limited in Shea Village Stittsville or Place St. Thomas Embrun and who have a mortgage/charge on that residence where the term of the mortgage/charge extends past June 30, 2024. Multiple Mortgagor(s)/Chargor(s) will be considered as a single entity for the purposes of eligibility no matter how many persons are listed on title as mortgagor(s) or chargor(s).

He/she/ they/it must be listed as mortgagor(s) or chargor(s) in a mortgage or charge registered against the title to their Valecraft Homes (2019) Limited built residence in Shea Village Stittsville or Place St. Thomas Embrun as above.

Excluded from eligibility are employees, agents and sales representatives of Valecraft Homes (2019) Limited ("Sponsor"), their advertising agencies, promotional agencies, fulfillment houses and prize suppliers, each of their respective parent, affiliated and related companies, suppliers of the materials and services related to this Draw, and members of the immediate families (defined as parents, siblings, children and spouses, regardless of where they reside) or households (whether or not related) of such employees, agents and sales representatives.

3. HOW TO ENTER

NO PURCHASE NECESSARY.

Internet access may be required for some entries. During the Draw Period enter through the Valecraft Homes (2019) Limited website at valecraft.com (the "Draw Website") or by visiting a Valecraft Homes (2019) Limited Design Centre in either Shea Village Stittsville or Place St. Thomas Embrun To participate as an existing 2023/2024 Mortgagor/Chargor complete the entry form and submit so it is received no later than 11:59:59 p.m. (ET) on June 30, 2024 ("Draw Closing"). Alternatively, you may write to Score Your Mortgage Payments for a Year Draw, c/o Valecraft Homes (2019) Limited at 1455 Youville Drive, Suite 210, Orleans, On K1C 6Z7 for a free entry form and one will be mailed to you within 5 business days after receipt of your request. For these types on entries, only validly completed entries delivered by mail or by hand to the address above by 4:00 p.m. June 30th, 2024, will be deemed to have been received before Draw Closing.

LIMIT: One entry per Mortgagor(s)/Chargor(s) per Valecraft home (defined above).

Use of automated devices is prohibited; automated entries (including but not limited to entries submitted using any robotic, script, macro, or other automated service) are not permitted and may result in disqualification.

4. HOW TO WIN

On **July 4th, 2024**, at or around 11:00 AM ET in Ottawa, Ontario, a random draw will be conducted by the Draw Judging Organization from all eligible entries received during the Draw Period. The odds of being selected as eligible to win a Prize will depend on the total number of eligible entries received. If you are selected as eligible to win the Prize, you will be contacted by the Draw Judging Organization within approximately three (3) to five (5) business days through the details in the Valecraft Homes (2019) Limited files or on the Draw entry form. If the Draw Judging Organization cannot reach the potential winner, or if the potential winner does not respond within the timelines required by the Draw Judging Organization, then a new potential

winner may be drawn at the discretion of the Draw Judging Organization and the initial potential winner shall have no recourse against the Sponsor or the Draw Judging Organization. See prize claim conditions below.

5. PRIZE CLAIM CONDITIONS

Before being declared the winner of a prize, each selected entrant must first correctly answer, without assistance of any kind, whether mechanical, electronic, or otherwise, a time-limited mathematical skill-testing question to be administered by the Draw Judging Organization by email at a mutually convenient time. There is one (1) prize available to be won, consisting of payments of principal and interest (exclusive of penalties, taxes of any kind, insurance of any kind or any other payment not considered by a Canadian chartered bank to be within the ordinary commercial definition of principal or interest) during 2024 on behalf of the winning Mortgagor(s)/Chargor(s) (as defined above) to a registered Mortgagee/Chargee or Mortgagees/Chargees against the Mortgagor(s)/Chargor(s)'s Valecraft home to a maximum of two thousand and fifty (\$2,050.00) dollars during any calendar month and to a maximum of twenty-five thousand (\$25,000.00) dollars during the calendar year 2024. As the prize is one of continuing mortgage payments for a year, a winner must provide Valecraft, and at least once at the beginning of each calendar quarter, with proof acceptable to Valecraft that the subject mortgage continues to exist and is good standing. A default under a mortgage, or prepayment of a mortgage, will result in termination of the prize.

This prize is not assumable or transferable and will cease upon either the sale by the winner of the qualifying Valecraft Homes (2019) Limited built residence or discharge of the mortgages/charges against such residence.

If the selected entrant fails to qualify for the prize or, having qualified, ceases to qualify before the first payment described above is made, then the Draw Judging Organization shall draw another potential winner and the provisions of the Official Draw Rules, including paragraph 5 above, shall continue to apply to such newly selected potential winner.
